

### A-1 Building a Plan for Transitioning Students with ASD to Adult Services

John C. Barnard, M.S.Ed, BCBA and Jessica A. Fedezko, M.A., BCBA -The Bancroft School

The US Bureau of Labor Statistics has reported decreases in the number of individuals with developmental disabilities who are employed. Despite our efforts to prepare and support our learners for these opportunities. What are some reasons for these low numbers? And how have ongoing changes to our job market impacted employment opportunities for individuals with developmental disabilities? This session will attempt to answer some of theses questions by providing an overview of the structure of vocational programming and of adult day services. A roadmap of key skills and curriculum sequences will be proposed. It will be argued that preparation for an eventual transition to adult services is something that starts as early as elementary school and must be planned for at each and every step. Key behaviors and skills should always be taught that will benefit the learner in their next environment. Helpful hints will be provided for both educators and parents. Lively discussion will be encouraged.

#### A-2 Psychiatric Pharmacogenomics

Stephen M. Neff, MSN, APRN-BC, NP - Y.A.L.E School

Psychiatric pharmacogenomics is beginning to come of age. In brief, psychiatric pharmacogenomics takes very targeted data from gene sequencing to help tailor a medication to a patient's particular system/needs. Though still in its infancy (though we've been using this technology for over a decade), we are able to understand much more about how individuals process psychotropic medications and this understanding is already leading to improved efficacy and dramatic decreases in side effects and decreased time in finding suitable medications for people. In special populations such as children, adolescents and adults with neurodevelopmental disability this is an indispensable tool as these individuals are at greater risk for side effect or simply don't respond to medications in the way neurotypical patients do. This tool proves even more valuable as these individuals frequently can't tell us how a given medication is making them feel; tools like this give us some objective understanding on how to help avoid side effects in these populations.

#### A-3 The Active and Engaged Role of Teacher Assistants, One-on-One's and Paraprofessionals as Partners with Lead Teachers in Learning

This training experience shows all attendees how to create a healthy and responsible partnership that meets all children's academic, social, behavioral and emotional goals as a team effort. In other words, this training will prepare each attendee how to identify their own independent roles in providing classroom management as well as academic instruction. Overall goal ...motivating staff, managing different variables that we face in this profession while promoting student success!

## A-7 Implementing School-Wide Positive Behavior Supports in an Alternative Setting: Practical Implications for Success with Complex Students

Dr. Maura L. Roberts, Ph.D., Lana Altimari - Mary A. Dobbins at Legacy Treatment Services and Greg C. Llewellyn - Llewellyn Educational Consulting

Effective behavioral practices and school structures are critical to improving the outcomes of students served in an alternative education setting (AE). School-wide Positive Behavior Supports (SW-PBIS) offers a promising approach to improving student outcomes in an alternative setting (AE). While the implementation of School-wide Positive Behavior Support has achieved positive outcomes in general education settings along with growing evidence that it is also effective in alternative settings. Research has demonstrated that SW-PBIS can reduce office discipline rates for major problem behaviors for students. However, most studies report overall student outcomes rather than disaggregate the findings for general education versus special education students. The purpose of this workshop is four-fold: 1) Provide an overview of the SW-PBIS framework and essential components, 2) examine the impact of SW-PBIS in alternative education settings, 3) review the features of SW-PBIS appropriate for implementation in an AE, and 4) demonstrate the impact of SW-PBIS with a special education only population.

#### B-1 Using Behavior Skills Training (BST) to Scale Up the Implementation of Skill-Based Treatment (SBT) for Severe Problem Behavior in a School Setting

Edward Sidley and Ashley McParland - SEARCH Day Program

Severe challenging behavior can present significant safety concerns as well as barriers to learning in the school setting. The Practical Functional Assessment and subsequent Skill Based Treatment have been found to effectively decrease problem behavior and teach replacement skills in communication, toleration, and cooperation. How does a school or agency scale up the use of this program across students and the staff who support them? At SEARCH Day Program, behavior skills training (BST) is the model used to train both the trainers and the staff in the implementation of SBT. This presentation will discuss the need for quality treatment when faced with severe challenging behavior, a general description of PFA/SBT, how BST is used for staff training of PFA/SBT, a brief case study of 4 students in the program, and a description of what ongoing supervision/training looks like. Videos, data, and social validity will be presented and discussed.

Baseline and post-test probes will be further discussed on how to implement these assessments throughout the year to build individualized curriculum for your learners that require additional support by breaking down objectives into smaller units of learner through short term objectives. Examples of scoring, program sheets and objectives will be provided throughout the lecture. Behavior skills training will be modeled for the intended audience on how to create objectives while cross referencing assessment scores.

This class will review and refine skills required for success when working in the classroom and with students as a paraprofessional. Topics covered will include: prompting techniques and prompt hierarchy, various methods of data collection with examples and demonstrations, role in

implementation of behavior plans and sensory diets, portfolio set up and filing of basic evidence/data, and information related to current trends in technology used in the classroom during instructional work sessions, such as, SMARTBoard & iPads.

At CTC, we were able to adapt and individualize lessons in music and art classes that focused on both theory and practice. This presentation will focus on a variety of lessons presented to students with a wide array of needs. Participants will see video examples of students creating art and music with the help of assistive technology. Attendees will also have an opportunity to trial the devices that were used. You will hear from both our art and music teachers as they share their instructional goals and their teaching philosophy. Finally, participants will leave with a toolbox of lesson plans that could be used both with and without specific equipment.
